In April of 2004 our beloved Eta Omicron House suffered a devastating fire. At that time the House Corporation, made the decision to rebuild. To accomplish this you, our alumni, stepped up and donated more than \$100,000. In January of 2006 our new house was opened and the future for our Chapter was very bright.

Unfortunately, given the current economic climate and occupancy challenges, our house is not sustainable without your help. The current financial projection shows that this will be the last year for this new house. Without alumni support, we will have to sell the house, which will most likely mean the end of the Eta Omicron Chapter after 36 years.

We need immediate help to save our Chapter and are asking each alumnus to make a \$100 donation to restore our reserves and save the house. If you can't afford \$100, send what you can. If you can send more, please do so.

If we fail to raise the funds needed to meet our operating expenses, the Board, at our annual meeting this October 31st, will be forced to vote to place the house and property up for sale.

The landscape of the University and student population has changed. As a fraternity at IUP, our economic reality is that we will need ongoing fund raising support from our alumni to sustain our house and Chapter for now and the foreseeable future. Our goal is to raise \$20,000 annually with this effort.
